Please find below the current Self Drive Hire, hire process for your consideration;

Documentation to retain from each driver:

1. Copy of the photo card drivers' licence (Address & ID must be up to date)
2. DVLA Online licence check -<https://www.viewdrivingrecord.service.gov.uk/driving-record/licence-number>

3. Two forms of proof of address (Address must match the drivers licence)
4. The payment MUST come from the drivers bank account and be a cleared traceable security deposit (BACS, Credit/Debit Card, Paypal)
5. Signed Hire agreement

Two proof's of Address are required for Self Drive Hire, below are a list of documents which are accepted by our insurer.

If you only have one or do not have any of these bills/statements to available then please do not hesitate to contact us on 07359305664 I will then see what documentation you can provide, we will then contact our insurer to see if they would be accepted. Please allow ample time for us to do this on your behalf.

The 1st following One Utility Bill/Statement is acceptable for proof of address:

(Must be dated within 90 days of the hire date & we do accept Online Statements)

Primary Proof of Address:

- Electricity
- Water
- Gas
- Broadband/Landline
- Council tax
- TV licence
- Bank Statement
- Credit card bill / statement
- Mortgage statement
- Polling card
- HMRC self-assessment / tax credit

The 2nd following documentation is acceptable for proof of address alongside One Utility Bill/Statement:

(Must be dated within 90 days of the hire date & we do accept Online Statements)

Secondary Proof of Address:

- Student loan
- Shotgun licence
- Payslip
- Mobile Phone Bills
- Pension letters
- Car Finance Statement
- Loan Statement
- Property deed

Once you have these documents we do need an image of these along with just the front of your driving licence to WHATSAPP Emma 07359305664

Driver criteria:

1. All drivers must have held a full UK licence for a minimum of 36 months
2. All drivers must be aged between 21-75 Insurance Excess is £500.
2a. Drivers aged 23 & 24 the Insurance Excess is increased to £1000.
3. Drivers can have up to 6 points on their licence (providing they are two minor offences)

The cleared and traceable payment method requirement relates to the theft of vehicle aspect, so in the event of theft by hirer it is possible to trace who made the payment and where it came from.
